**Rental Agreement and Liability Waiver** It is the responsibility of the person or organization hiring this inflatable equipment to ensure that all possible precautions are taken to avoid injury to people or damage to the Inflatable. Please ensure that the following Safety Instructions are followed:

1. No food, drink or chewing gum on or around the Inflatable. (Please note if the inflatable is collected in a dirty condition then the person hiring it will incur a cleaning charge)
2. Shoes, glasses, jewelry, and badges **MUST** be removed before using the inflatable.
3. No face paints, piñata, party poppers, confetti, colored streamers or silly string to be used either on or near the Inflatable.
4. NO smoking on or around the Inflatable, NO barbeques around the Inflatable.
5. Climbing, hanging or sitting on walls is dangerous and **must not be allowed**, Do not allow anyone to bounce on the front safety step as this is dangerous.
6. A responsible Adult must supervise the inflatable at all times.
7. Always ensure that the Inflatable is not overcrowded, and limit numbers according to the age and size of Children using it.
8. Ensure Children are not pushing, colliding, fighting or behaving in a manner likely to injure or cause distress to others.
9. No pets, toys or sharp instruments on the inflatable at anytime.
10. Do not allow anyone to be on the inflatable equipment during inflation or deflation as this is DANGEROUS.
11. Please ensure that Children are not attempting somersaults and are clothed appropriately and that nothing can fall out of their pockets.
12. In the event that the blower stops working, please ensure all users get off the inflatable immediately and calmly. Check your breaker(s) and make sure the blower tube or deflation tube has not come undone or something has not blown onto and is obstructing the blower. In the event that it overheats, or loses power, switch the blower off at the mains, then switch it back on again 1 or 2 minutes later, and it should restart. If it does not, inform us immediately at (915) 892-0299.

4. Customer agrees to reimburse EpLittle Jumpers Party Rentals for all attorney fees, an amount not less than 50% of all sums due, court cost and expenses incurred by EpLittle Jumpers Party Rentals to enforce collection or to preserve or enforce rights under this contract.
5. Customer agrees not to loan, sublet or otherwise depose of equipment or use it at any other location (DO NOT move equipment WITHOUT company permission),
6. Customer agrees to pay in full the replacement cost, including labor, for all damages to rental equipment.

Full payment is **REQUIRED** at delivery time without exceptions (cash, card and paypal accepted \*processing fee applies on all electronic transactions\*) Client is **RESPONSIBLE** to call and pay if payment was missing at setup time. Full amount **MUST** be pay NO later than the next day of reservation by 6pm by electronic payment. After final due date ALL missing payments would be subject to **late fee charge of \$30 dills** (same amount would be charge every 3<sup>rd</sup> day)
